

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

ALIGHTED FROM MY VEHICLE AND REMEMBER A VEHICLE BEHIND (SHB 6727S) HAD COLLIDED TO THE REAR OF MY VEHICLE AND PUSHED ME FORWARD AND HIT ONTO THE VEHICLE INFRONT.
