Dear Cynthia,

We are forwarding the above case for GIA deliberation (no applicable scenario).

Date, time & place of accident: 31/05/2014 at 19:46 hours along Telok Blangah Road towards Vivo City

We summarise as follows:-

SHC 4406B (SMRT taxi) reported – travelling along Telok Blangah Rd at slow speed due to heavy traffic jam. While moving slowly, SFV 2918C cut into his lane and grazed onto the left rear portion and continued to drive off despite high beam.

SFV 2918C (AXA) reported – travelling on the left most lane waiting to enter Vivo City car park. SMRT taxi cut in between his car and the car in front of him and grazed his car.

Damage to SHC 4406B - left portion

Damage to SFV 2918C - right front portion

We attach the accident report of SHC 4406B, photographs showing the damages to SHC 4406B. Video footage will be sent by post.

We have written to LKK Auto Consultants Pte Ltd on 24/1/2018 to seek for consent from their principal but they informed us on 8/3/2018 that they still have not receive further instructions from AXA. We attach their email for your perusal.

We have rejected the third party's request for survey on 3/6/2014. To-date, there is no further response from the third party's owner or his repairer. We attach our email of rejection for your perusal.

AXA Insurance had maintained their rejection despite providing them with the video footage which clearly showed that their insured had moved off from stationary position.
