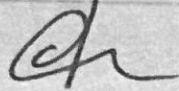

I was driving along KJE entering BKE towards PIE in
my car (plate no: SJW4161C) when a motorbike sped
passed me as I was entering the bend into BKE(PIE).
I was on the right most lane, and the motorbike
(plate no: FBL1069J) was on the left. The motorbike
was going too fast and was not able to negotiate the
