Thank you for the video clip.

There is no available video reported by TP.

From Ol's video, we observed OI was travelling within a lane where he may proceed straight or turn right.

TP on the other hand, was travelling from the left side of OI (a go-straight-only lane). We observed TP travelled too close to OI's lane giving us an impression of he is going to initiate a right turn or he will overtake the vehicle in-front to proceed to the rightmost lane.

Based on the video, our opinion is that TP is more liable for failing to maintain a margin of safety and failing to observe a proper look out as he slightly swerved his van to the right where our insured was travelling causing the collision.
