

We had explained to the Insured the liability which is not to her favour regardless she made a right/left turn as she was exiting from the minor road.



The Insured Ms Tan had explained to us that at the material time, the construction further down towards the junction of Marine Parade road was already completed and the main road is now a 2 way traffic in which she can make a right turn. Please refer to the below screenshot of the accident location grabbed from Google Map (red arrow shows where our Insured was coming out).
