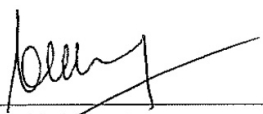

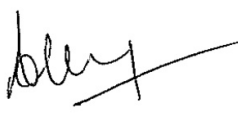
I understand, acknowledge, agree and consent that:

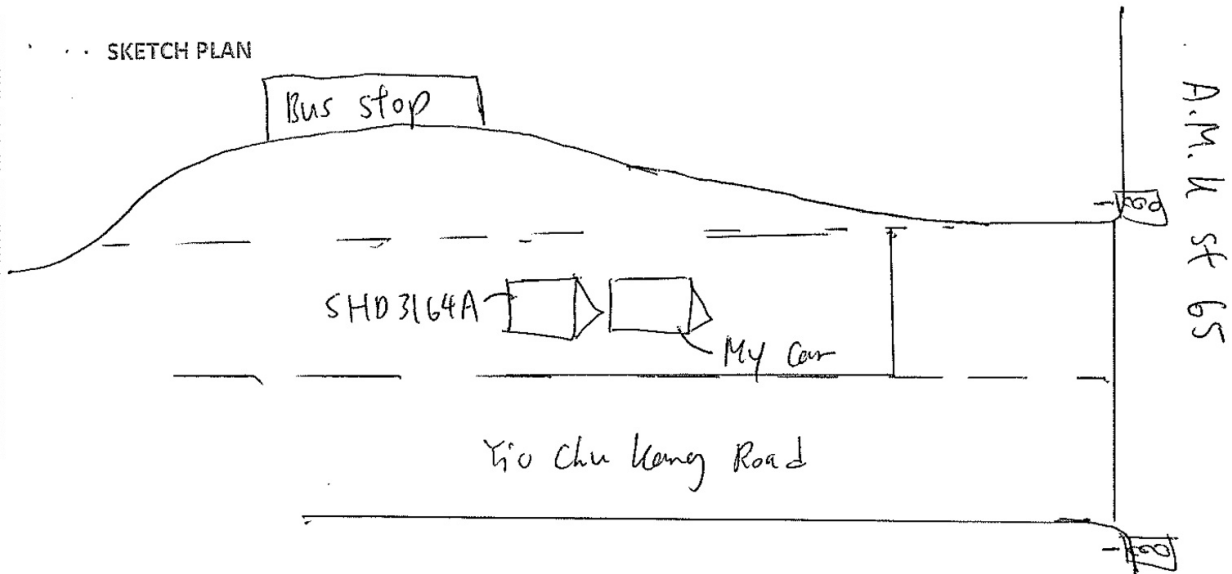

SKETCH PLAN



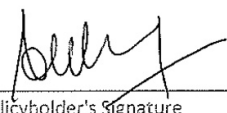
DESCRIBE CIRCUMSTANCES OF THE ACCIDENT
