



and my car was in ^{errand} lane

I stopped my vehicle in front of the traffic light. When the light turned green, I started to move off my car gradually, creeping to my lane. There was a white car on my left and stopped to turn right to left to Toh Tuck Road. A big truck was on my right at the same time. A motorcyclist from behind rode in between the lanes, i.e. the white car and my vehicle. When the white car stopped ~~to~~ slightly to his right, the motorcyclist attempted to still squeeze through between ~~the~~ two vehicles. He swerved to my car and hit my side. I was creeping to my lane with ~~the~~ and there was a big truck on my right and the white car on my left stopped to turn left.


