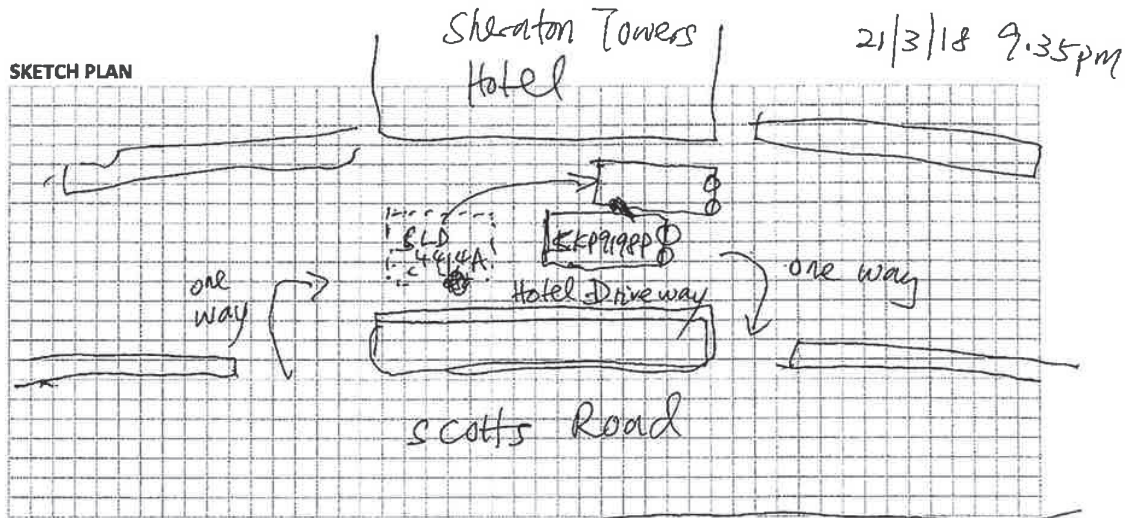

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

- At 9.35pm, my car SKP9198P was stationary. My fellow passenger (a large 1.9m American) was trying to get off the car. His name is Lou Lutostanski (tel +1-512-845 4434). Due to his size, it took longer than expected to get off. While pushing the door open, SLD4414A zoomed ~~past~~ past from left hand side trying to squeeze through. Lou Lutostanski saw the headlights & tried to pull back the door, but ~~was~~ was too late and the front passenger's door clipped the ~~back~~ right side back door of SLD4414A. Without quick actions from Lou, SLD4414A could have knocked him & car door down.
