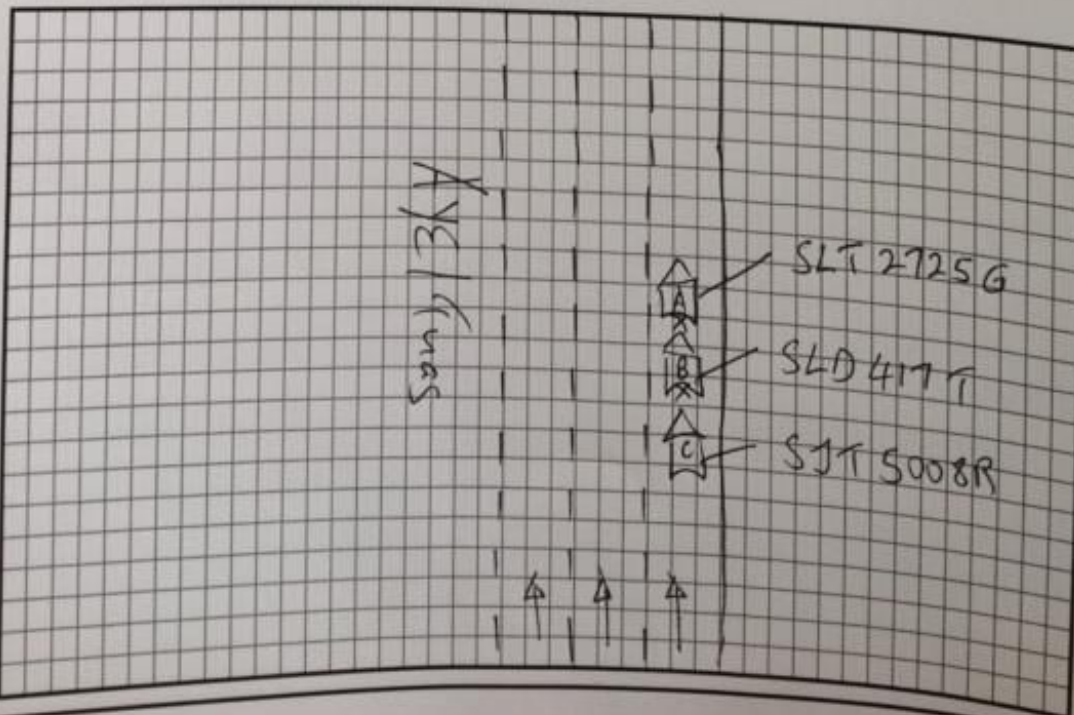

### Brief Details.

On 24/03/2018 at about 1540hrs, I was travelling along AYE towards Tuas on the right most lane when the vehicle travelling in front of me had braked. Thus, I had managed to brake and did not hit into his rear. Shortly after, I felt an impact from the rear and there was a vehicle which had hit into the rear of my vehicle. I thus made a check and discovered that it was a chain collision involving 2 other vehicles. There were no immediate medical attention required at that point in time and no ambulance was activated. We exchanged the necessary details and left shortly after. After which, I felt pain on my neck and back and thus went to seek medical attention and was given 3 days of MC. That is all.
