CONTINUATION OF REPORT

Brief Details.

On 22/03/2018 at around 1820hrs, I was driving my vehicle, SGE5234A along Pan Island Expressway towards Tuas opposite Toa Payoh swimming complex. At the point of time traffic was very heavy hence everyone was stationary or moving at a slow speed. I was stationary when I felt an impact. I then realize that a 3rd vehicle, WYC9328 had collided into the rear of a 2nd vehicle, SJL9881H causing it to surged forward and collided into my rear.

All three drivers came to a stop and alighted to make a check on the situation and exchange particulars. Traffic police then arrived shortly to render assistance. At the point of I was not injured. I notice the driver of the 2nd vehicle and passenger of 3rd vehicle seems to be having discomfort.

There is a in car camera installed in my vehicle and it did captured the accident. I had already forward the video to the traffic police at scene. I was given a case card with report number E/20180322/0119 and the IO in charge is IO Abdilah (HP: 83832412). Subsequently, I was advised to lodge a traffic accident report.
