

Brief Details.

On the 20/03/2018 at about 1245hrs, in front of unit 75 Neil Road, I was trying to parked my vehicle a silver-grey in colour BMW 535i bearing plate number SKN7001Y in parking lot 11. However at that time, there was a white in colour Mercedes Taxi bearing plate number SHA3935H was parked in lot 10 and it occupied partially in lot 11. The parking lot was for parallel parking.

As I was reversing in the lot, I honked at him to move forward and which he did but it was insufficient for my car to be parked in the lot. I tried to maneuver my car in the lot but was unable to. I proceed to alight my vehicle to knock on the taxi's window to request him to move forward which he did not move forward and it was tinted hence I was unable to get to see what is inside.

I went back to my vehicle and tried to squeezed my vehicle into the as much as I can but was unable to. My vehicle was at the rear of the taxi and partially in the lot. That was then I went to the taxi driver door, and opened his door to inform him to move forward more. The driver then refused to move forward even though there are sufficient space to move forward. The driver then closed his door, reversed his vehicle and it hit the center bumper of my vehicle. He then reversed again which cause his vehicle to hit the passenger side of my front bumper which cause the water-jet cap to came off and cracks on the bumper. The driver subsequently drove off even though I told him to stay as I called for police's assistance.

When I tried to block him to prevent him from leaving, the driver tried to ran over me.

The traffic police arrived shortly after I called and was given a case number A/20180320/0083 under IO Rashidah. I was advised to lodge a traffic report.

I wish to state that I have the footage and pictures of the incident recorded my handphone. My vehicle did not have any in-car camera. As of now, I am unsure of the cost total damage caused.
