CONTINUATION OF REPORT

Brief Details.

On 16/03/2018, at about 2230hrs, I was riding on the lane 2 with my motorcycle FBL9509D with my pillion rider fiance, Juliana Bte Samuhi NRIC S8431821C HP: 96659403 along Central Expressway towards Seletar Expressway when I noticed there's a blue comfort taxi SH9622D in front of me travelling straight. Out of sudden, due to the car in front of the blue taxi, that braked suddenly and makes a sudden left turn, the blue taxi also make a left turn. This caused me cannot react on time and knocked onto the blue taxi left side mirror.

Upon this impact, at the same time, there's a Malaysian registered green Kawasaki motorcycle from my back and knocked onto my motorcycle box which is behind my fiance sitting. I cannot remember what is the Malaysian motorcycle plate number.

Both of us fall down on the road on our right side. Both my fiance and me were injured.

After this happened, the taxi driver called for the ambulance and eventually the Traffic Police(TP) arrived. I was given a report number by the TP. The number is F/20180316/0244.

I never exchanged particulars with either the taxi driver or the Malaysian rider. I was then later conveyed to Tan Tock Seng Hospital to gether with my fiance.

Both my fiance and me were given 7 days Medical Leave. I broke my left thumb and right forearm suffered abrasion. My fiance suffered broken right arm and abrasion on her bottom right near the stomach area.


