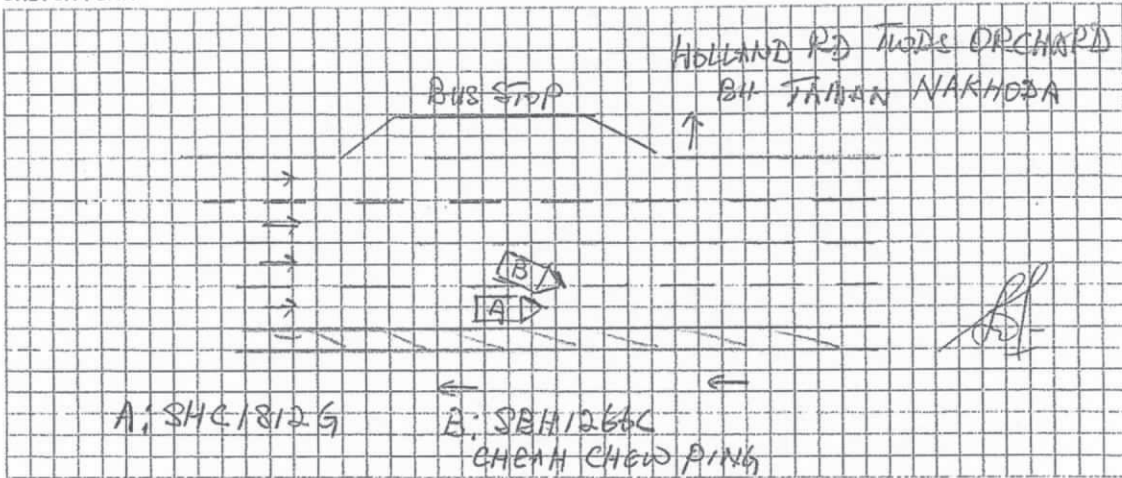

Describe Circumstances of the Accident.
On 27 Mar 2018 at about 08:45 hrs the traffic volume was heavy hence the traffic flow was
very slow moving at times it grinds to a complete halt.
Due to the traffic condition of the road my taxi came to a stop on the rightmost lane behind a
car SLD7541X along Holland Rd leading towards the direction of Orchard before the junction
Taman Nakhoda.
Shortly after the front car moved slowly forward hence I slowly moved forward as well.
Suddenly a Mercedes car SBH1266C coming from my left cut into my lane causing this accident
to happen.
As a result of this, the right hand side front of the car hit and grazed the left hand side front
towards the left hand side rear of my taxi. Both the left hand side wheels are damaged. The
ensuing impact subsequently caused the left hand side front door and the steering system to
be out of alignment.
