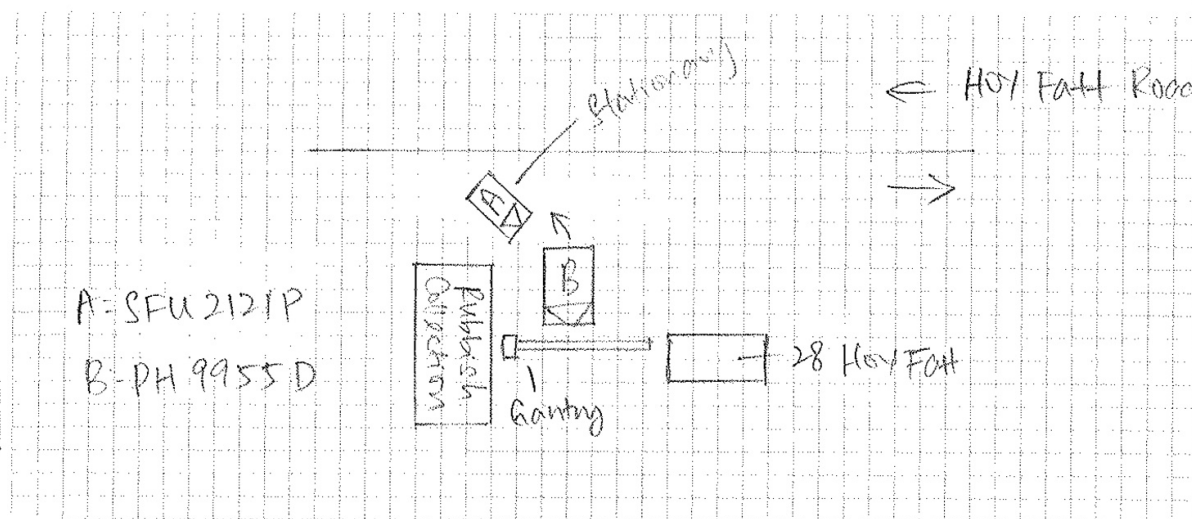
(d) my Personal Information will also be collected and used to compile claims history for the purpose of fraud detection, investigation and management in present and all future claims.

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On turning into the carpark at 28 Hoy Fatt Road, I noticed that vehicle PH9955D was stuck at the gantry. So I waited at the bend of the entrance, about 2-3 car lengths behind. This was to allow me to reverse back out onto the main road without much difficulty. After a few seconds, the driver got out of the car to alert the carpark of the stuck barrier. He acknowledged my presence as he got out. Once the barrier went up, the driver got back into the vehicle and started driving. At this point, the vehicle he was in started reversing. I honked to alert him but it was too late. He reversed into my car, SFU 2121P.

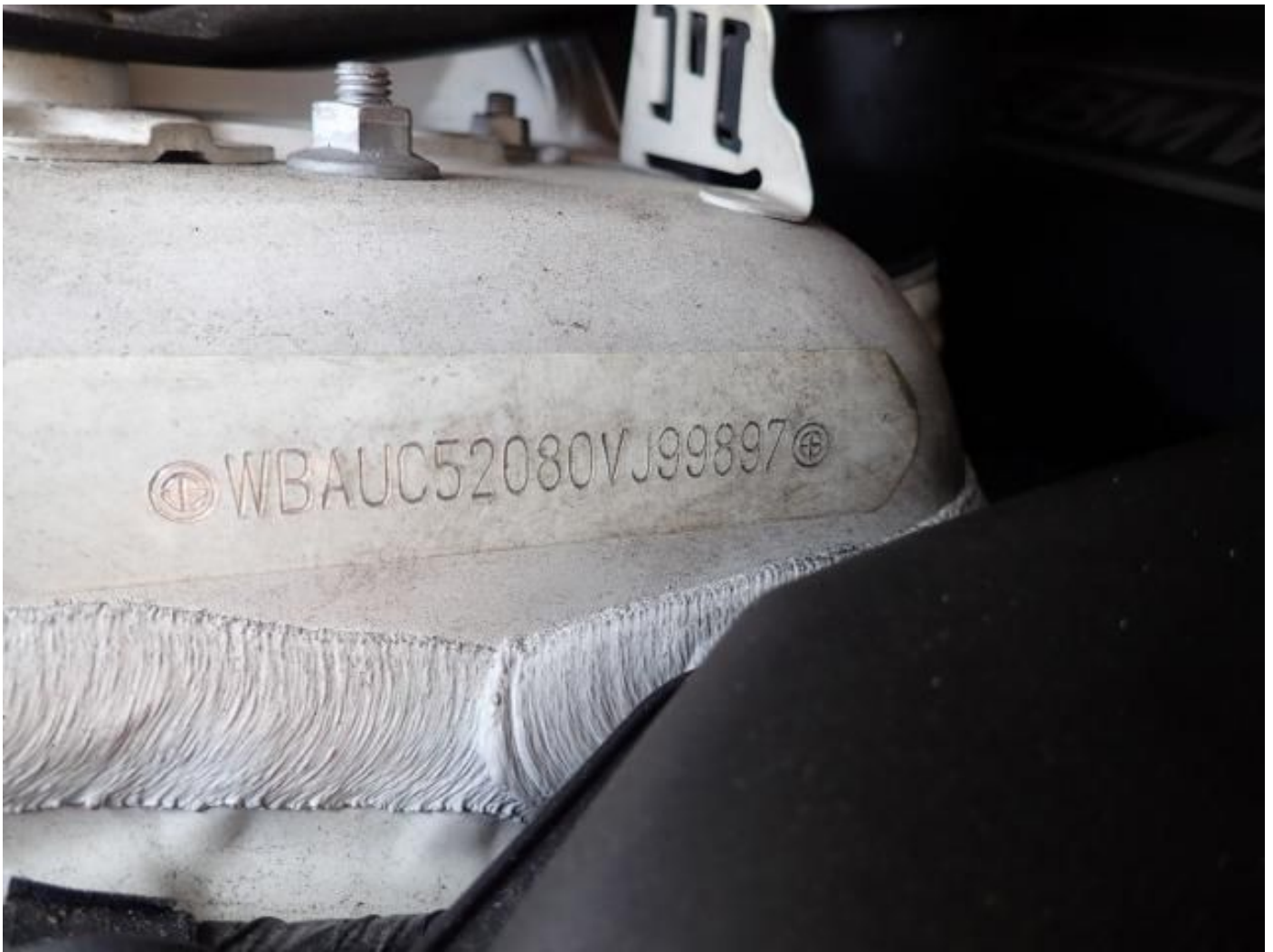

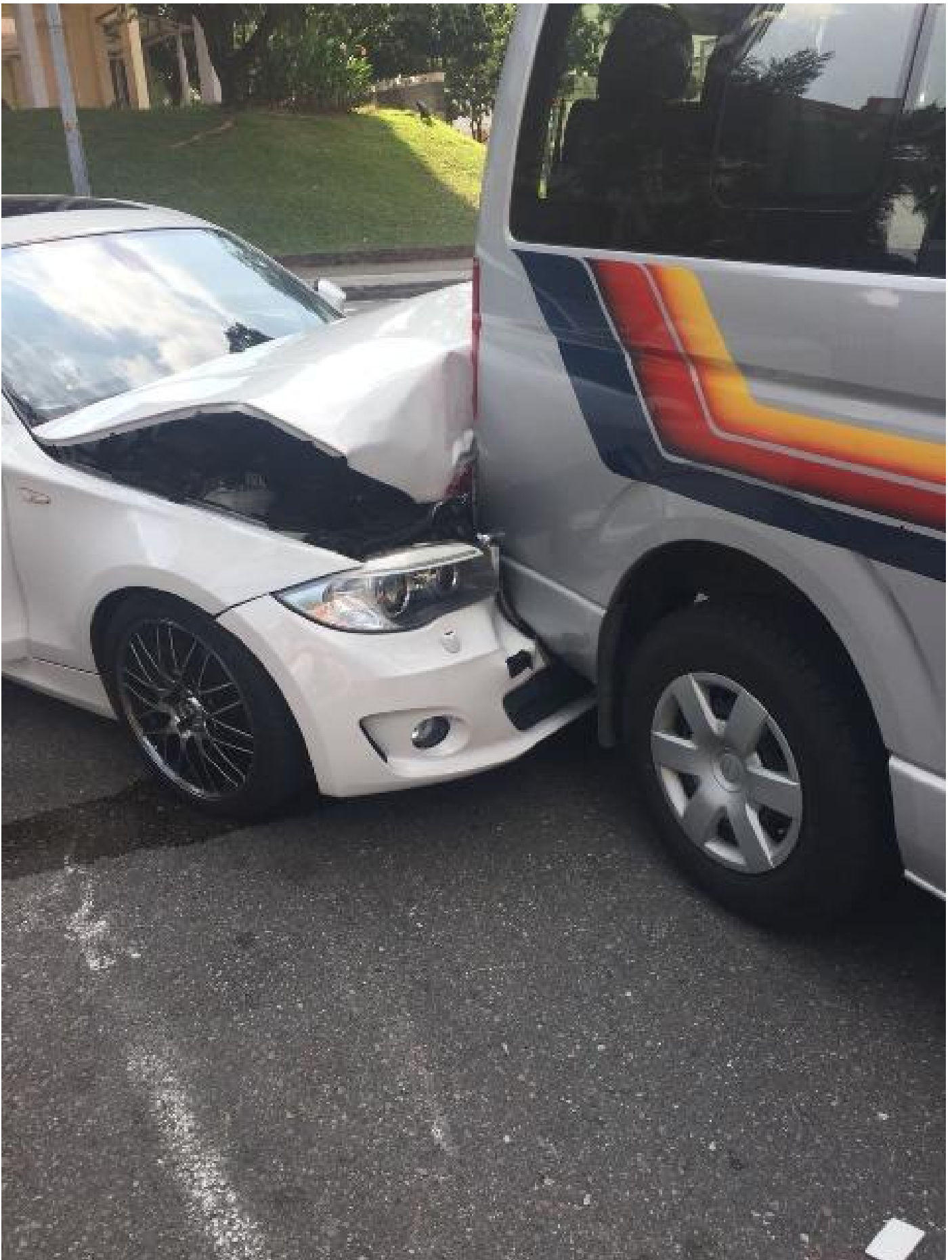
