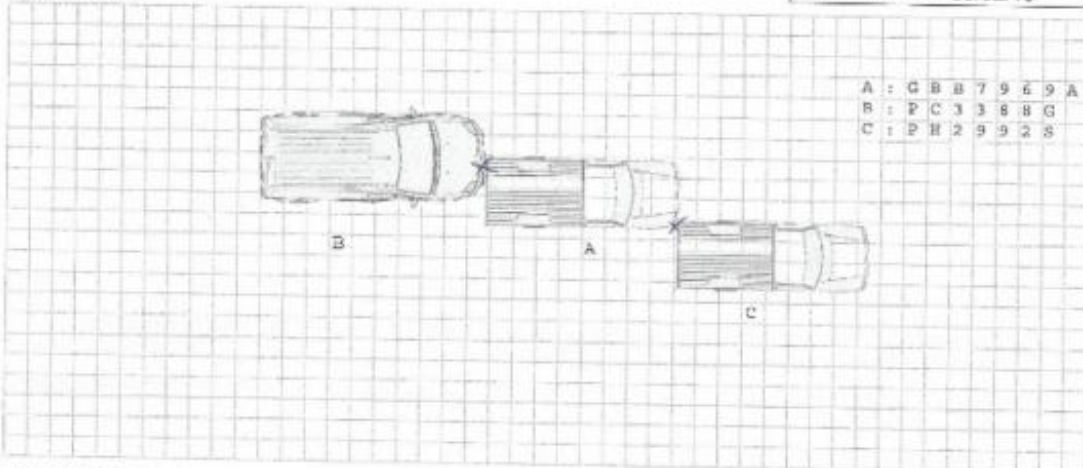

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

ON 09/02/18 AT ABOUT 0704 WHILE I WAS TRAVELLING ALONG BUKIT BATOK ROAD (NEAR THE FLYOVER) AND SLOWING DOWN AND ABOUT TO STOP. VEH B (PC 3388G) COMING ON THE BACK SUDDENLY HIT MY REAR LEFT SIDE. VEH B SAID HIS BRAKE COULD NOT BRAKE PROPERLY AND COULD NOT STOP ON TIME. ON THE IMPACT MY VEH JERKED AND HIT VEH C IN FRONT (PH2992S) VEH B DRIVER CAME DOWN AND APOLOGISED FOR CAUSING THE ACCIDENT.
