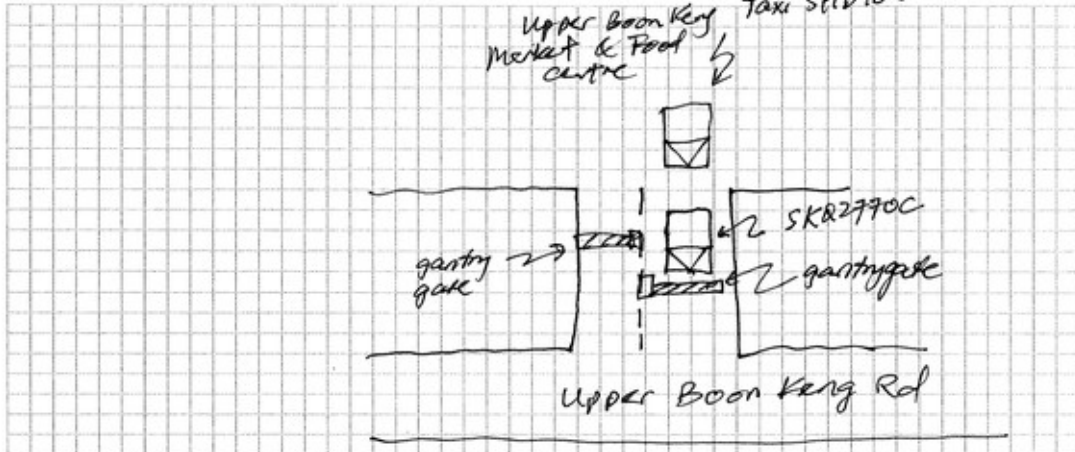

Upon exit at the carpark gantry, as the gate did not open suspecting the car I was not able to detect properly, he reversed the car and released hit a taxi SHD18J behind his car. Later they drove out of car park as blocking the exit to the main road of upper Boon Keng Rd to take photos.
