I then made a check on my vehicle and discovered that there was some scratches at the front left bumper area. I then contacted the said number, a Mr Toh picked up and he told me about the incident as his vehicle rear car camera had capture the accident. He then whatsapped me the video for my own use. The video was about 1 min long and it shows a red Mazda reversing to park and had accidentally hit unto my vehicle. According to the witness, the vehicle owner did not leave any note on my car. The witness was there too to find a parking space. There was nobody injured. When I had went back to my car, the red Mazda was no longer at the said carpark. My vehicle has a front in-car camera however once I turned off my engine it will stop working. It only works while the engine is running. The video also shows that the vehicle was in the opposite direction of the carpark direction. arrow. 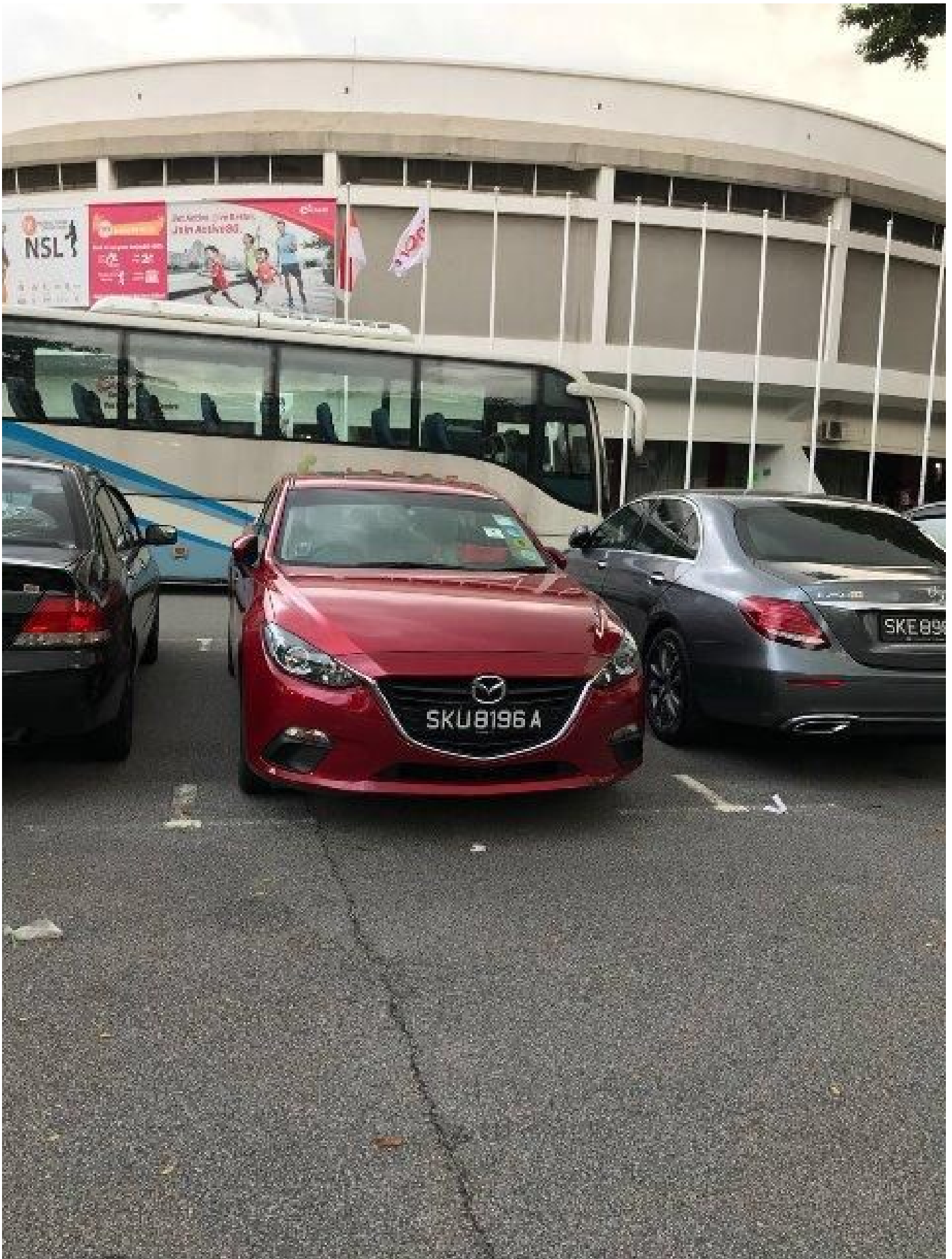

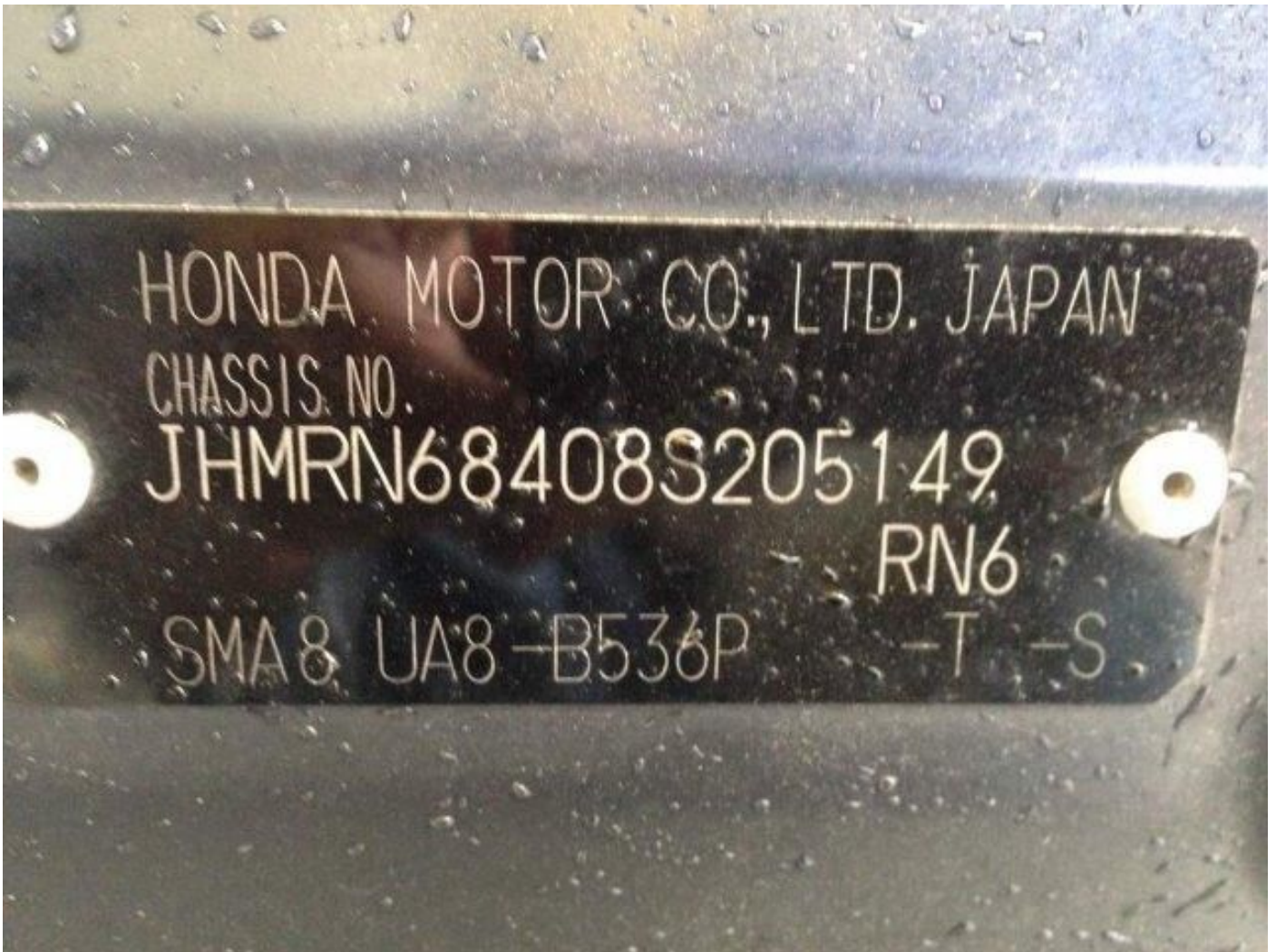
