SKETCH PLAN

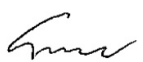


DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was driving along CTE and following to Bukit Timah exit at about 40kmh. Suddenly my car was hit at the back with a loud bang.

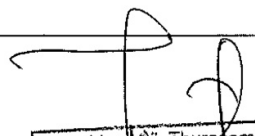

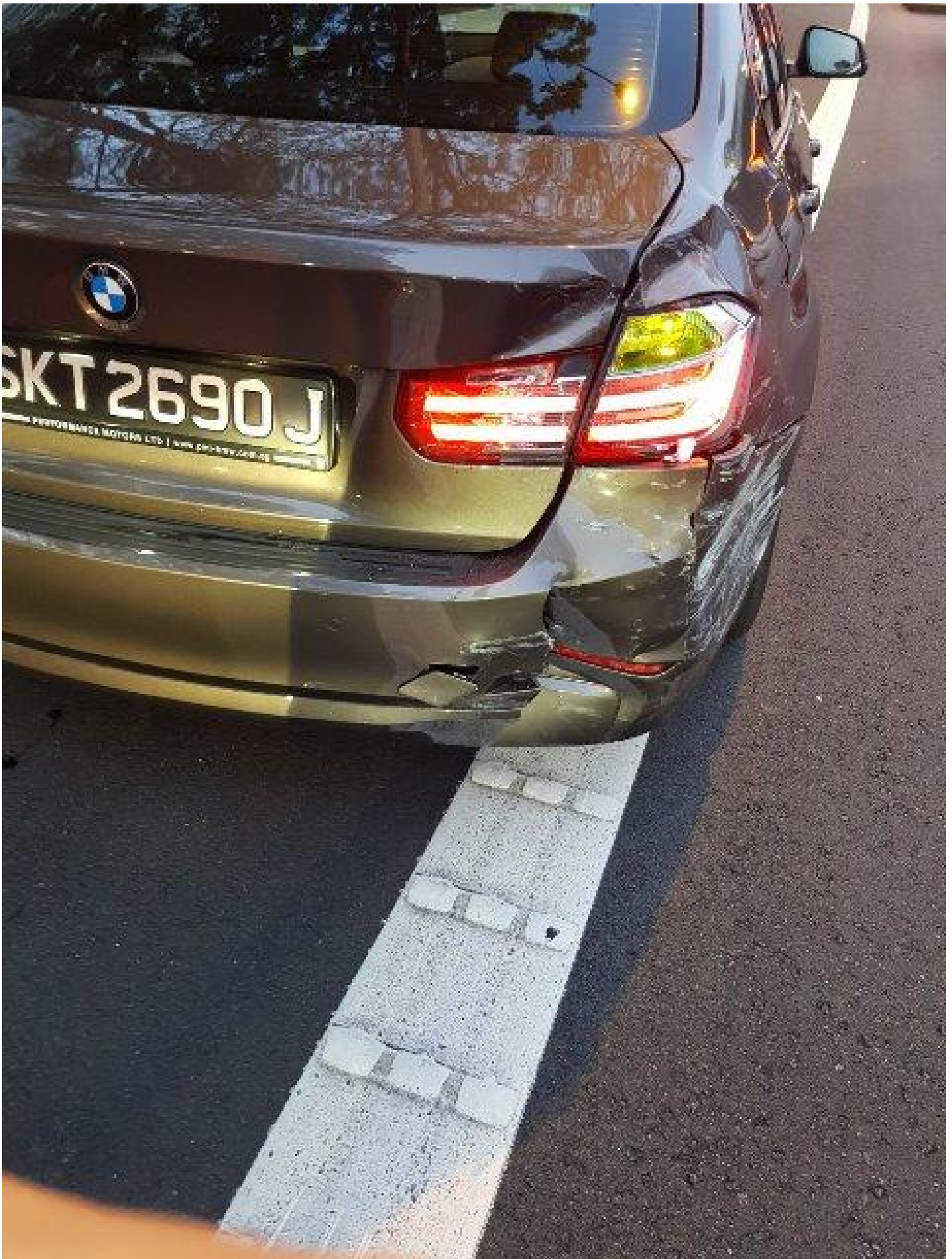

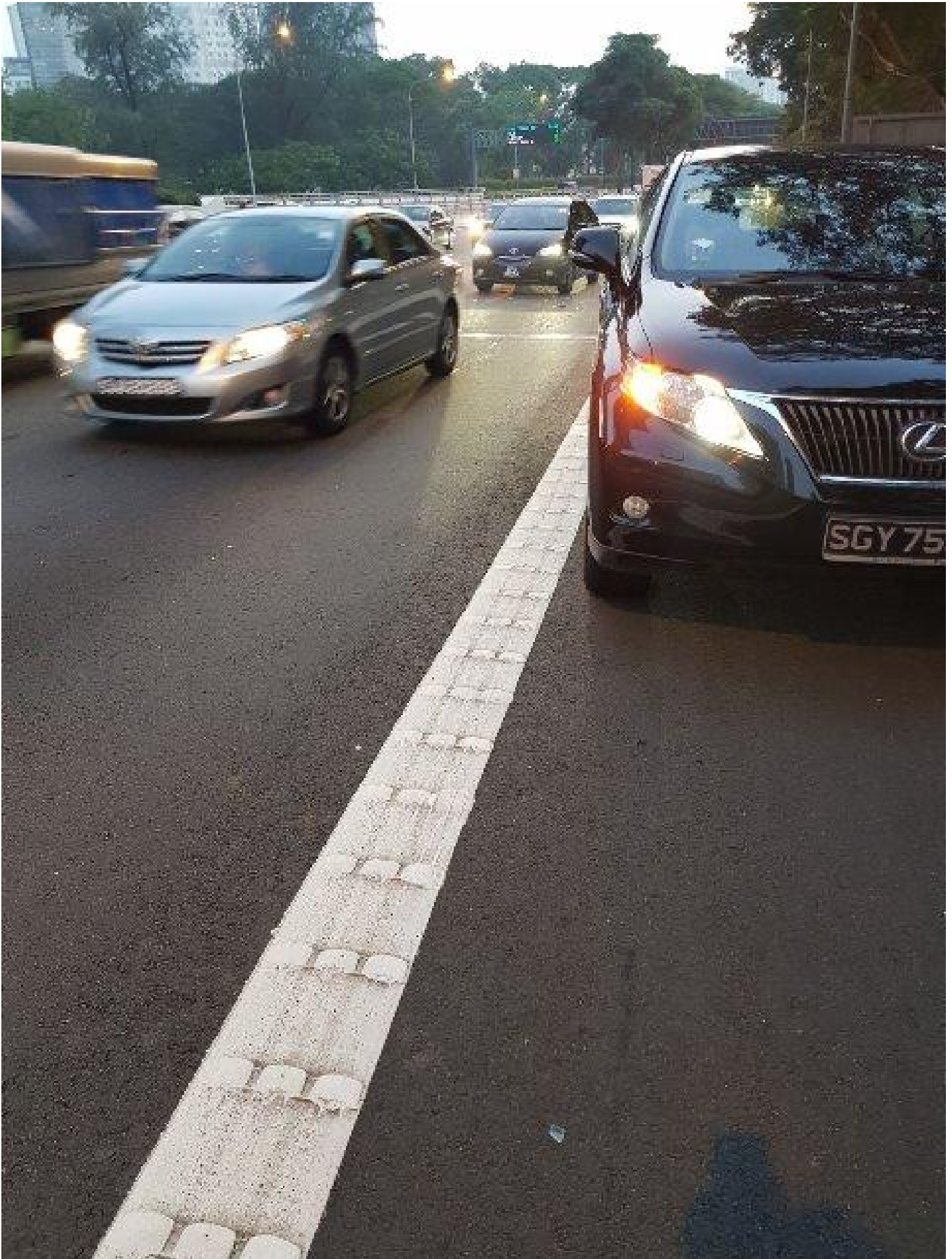
