We refer to the above matter.

Third party driver reported that he stationary in a road congestion due to parked vehicles on the left side of the road. OID who was on the opposite direction grazed the right reart portion of his taxi.

OID reported that he was driving along Martia Road. Third party encroached into his lane and resulted the collision.

We have contacted OID to verify the nature of accident. OID disputed third party claim as he was driving within his lane. Third party who was driving on the opposite direction had encroached into OID's lane and caused the accident. No video footage from OID.

We have reviewed the matter and our opinion is as follows: -

• Third party taxi while overtaking parked vehicles encroached into path of OID coming from opposite direction. Third party being an overtaking vehicle should exercise more care to avoid vehicle from the opposite direction.

In view of this, we are intending to reject third party claim.
