



Describe Circumstance of the Accident.

ON 31/03/2018 @ 1340 HRS, I WAS DRIVING MY TAXI (SHB 8838 S) TRAVELLING ALONG BT BATOK ROAD AT THE TRAFFIC LIGHT JUNCTION OF PAVILION CIRCLE, IN THE RIGHT LANE WITH 2 PASSENGERS ONBOARD.

I STOPPED MY TAXI AS TRAFFIC LIGHT WAS RED AT THE POINT OF TIME.

WHILE STATIONARY FOR MORE THAN 5 SECONDS, SUDDENLY I FELT AN IMPACT FROM THE REAR.




