Describe Circumstance of the Accident.

ON 02/04/2018 @ 1535 HRS, I WAS DRIVING MY TAXI (SHC 6413 S) TRAVELLING ALONG THE SLIP ROAD OF UPPER SERANGOON ROAD INTO BUANGKOK DRIVE.

I STOPPED MY TAXI BEFORE THE GIVE WAY LINES – GIVING WAY TO ONCOMING VEHICLES APPROACHING FROM THE RIGHT.

WHILE STATIONARY, SUDDENLY I FELT AN IMPACT FROM THE REAR.

WHEN INSPECTED, I DISCOVERED THAT VEHICLE B (SGS 1253 Y – NISSAN LATIO) WHICH WAS BEHIND ME, HAD COLLIDED ONTO THE REAR OF MY TAXI.

DUE TO THE IMPACT, MY TAXI HAD DAMAGES ON THE REAR PORTION AND VEHICLE B HAD DAMAGES ON THE FRONT PORTION.


AS A RESULT, I FELT UNWELL AFTER THE ACCIDENT AND WILL SEEK FOR MEDICAL TREATMENT.

NO AMBULANCE AT SCENE.


NO PASSENGERS ONBOARD BOTH VEHICLES.
