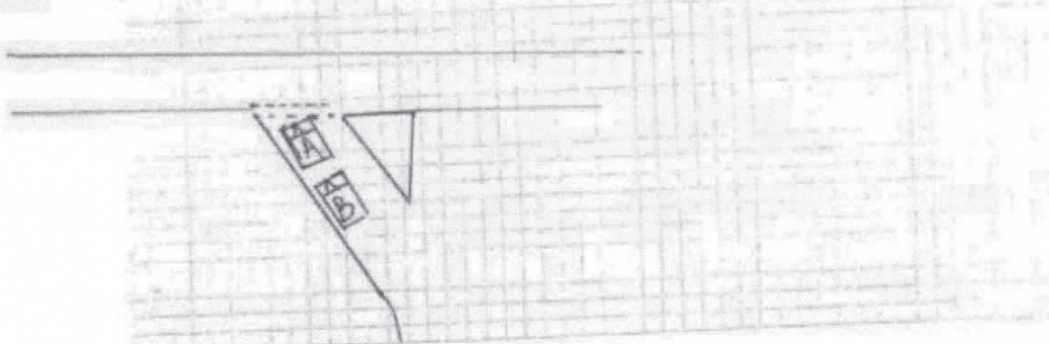

SKETCH PLAN

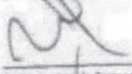


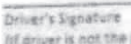

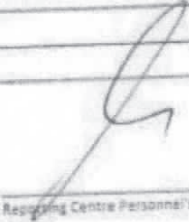
