



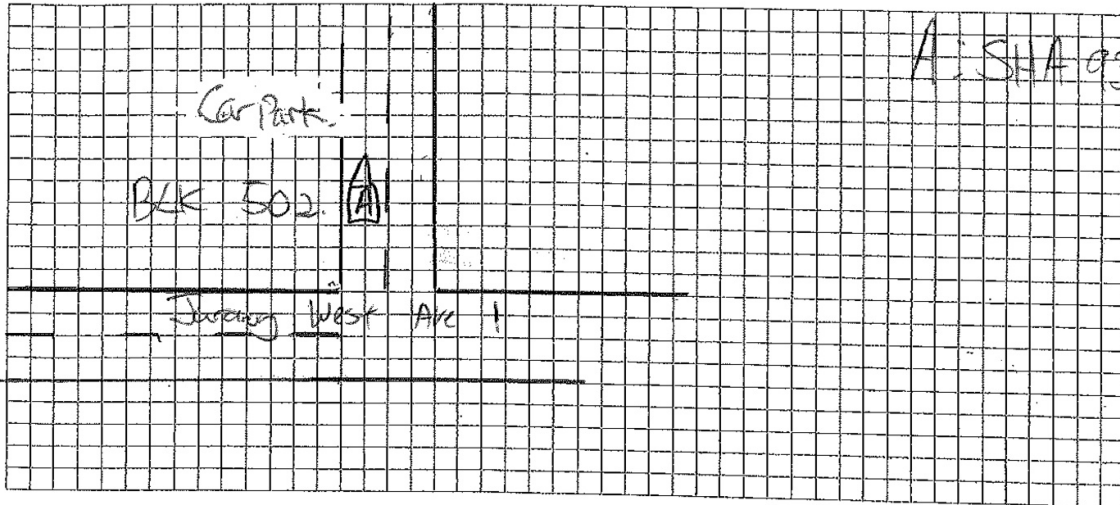

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT


On 4th March 2018 at about 1950 hrs, I was ferrying my passenger from Goring Road to Jury West Ave 1.
