We refer to the above matter.

It was reported that Insured vehicle was involved in a 3 vehicle chain collision and was the 2nd car and was pushed forward from behind.

We had spoken to the Insured where he confirmed accident details, was informed of the TP claim and agreed to settle the matter. A letter was sent out to the Insured company to notify TP claim and NCD issues.
