We refer to the above subject matter. We write to inform you that we are the loss adjuster appointed by your motor insurer, AIG Asia Pacific Insurance Pte Ltd to deal with the Third-party claim against your policy.

We have received a claim from Body Repairer/Workshop acting on behalf of the owner of GX 5235Y against your motor insurance policy.

We also refer to the following below for your information:

- We had spoken to you on 13/09/2016 where we were informed that the report was not lodged yet. On the telephone conversation, we were informed that there was a slight touch between both vehicles and that you didn't consider it as an accident as the other vehicle got dent on the rear portion which is already there prior to the collision. However, during the accident reporting, it was reported that there was no accident.
- We made follow up phone calls to you to discuss the matter on 09/05/2017, 29/06/2017 and 17/07/2017 but to no avail.
- Based on the scene photos provided to us by the claimant, we are of the view that the damages sustained to the Third-party vehicle is likely consistent based on the height observed on the front protruding portion of your vehicle and the dent observed to the tailgate of the Third-party vehicle.

Based on the accident report, accident scenario and all available information at hand, we are of the view that there was contact between both vehicles. As such, liability may not be on your favour.

Please be informed that your No Claim Discount (NCD) may be affected as a result of the claim against your policy.

We shall proceed to deal with the claim(s) subject to the merits of the case and according to the rights afforded under the policy. Should you not be seeking the protection of your policy and seek to take conduct of third party claim(s) arising from this incident, at your own cost and defense, please reply to us within 7 days from the date of this letter.
