Brief Details.

On 31 Mar 2018 at About 9.30pm, I was driving my vehicle, SHD389M, along Outram Road (direction towards Chinatown) on the left most lane. I stopped at the slip road leading towards CTE as there were pedestrians crossing the zebra crossing. Suddenly, I felt an impact coming from behind my vehicle. As I was stepping out to make a check, I saw the car that had collided onto my vehicle (SLL1786D) driving off. My vehicle sustained a dent on the bumper. Due to the collision, I felt stiffness on the rear of my neck when turning my head and also lower back pain. I sought medical attention at POW Family Clinic & Surgery and was given 4 days of MC.
