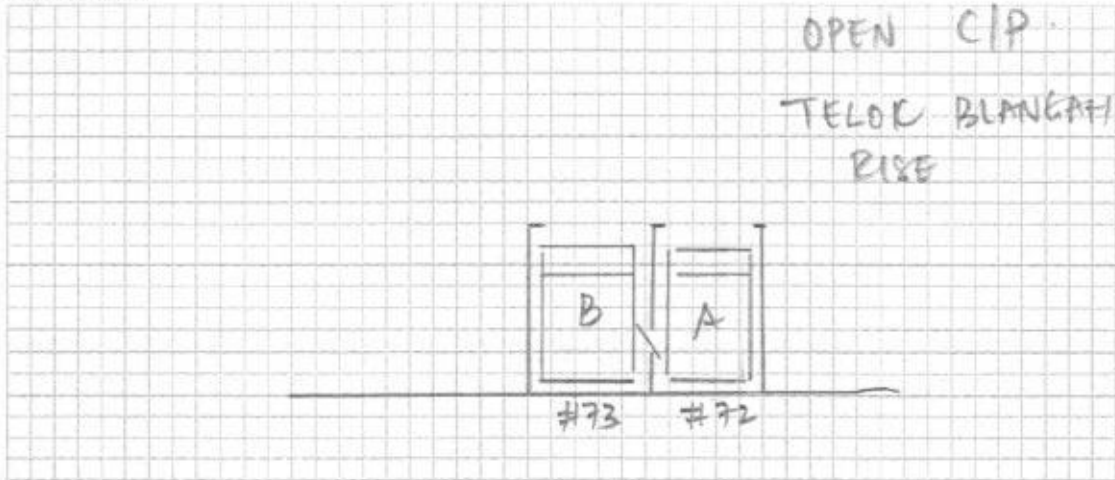

ON 04/04/2018 @ 1045HRS, I WAS IN MY TAXI (SHC 6923 L) STATIONARY IN A VERTICAL PARKING LOT @ TELOK BLANGAH RISE.

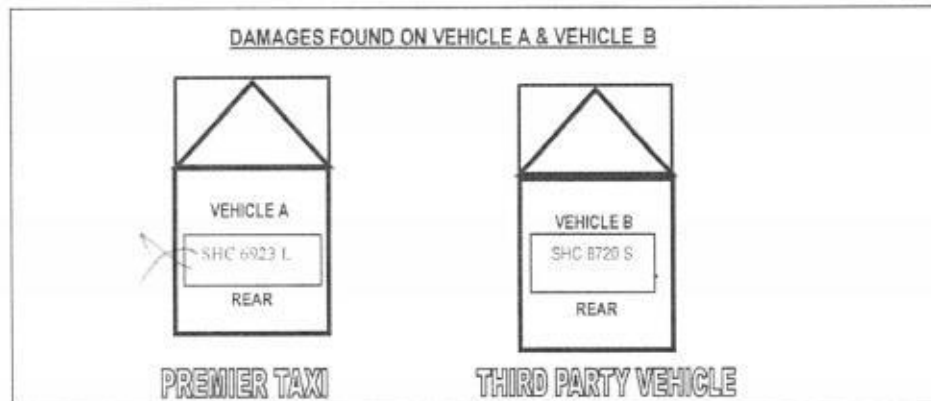
AFTER CHECKING FOR CLEARANCE FROM THE DRIVEWAY AND WAS MOVING OFF AHEAD, SUDDENLY I FELT AN IMPACT ON MY LEFT.

WHEN INSPECTED, I DISCOVERED THAT DRIVER VEHICLE B (SHC 8720 S – COMFORT TAXI) WHICH PARKED ON MY LEFT LOT, WAS CLEANING THE EXTERIOR OF HIS TAXI – FAILED TO KEEP FOR PROPER LOOK OUT HAD OPENED THE REAR RIGHT DOOR. AS SUCH, THE REAR RIGHT DOOR OF VEHICLE B HIT AGAINST THE LEFT PORTION OF MY TAXI.

DUE TO THE IMPACT, MY TAXI HAD DAMAGES ON THE LEFT PORTION AND NO VISIBLE DAMAGES TO VEHICLE B.
