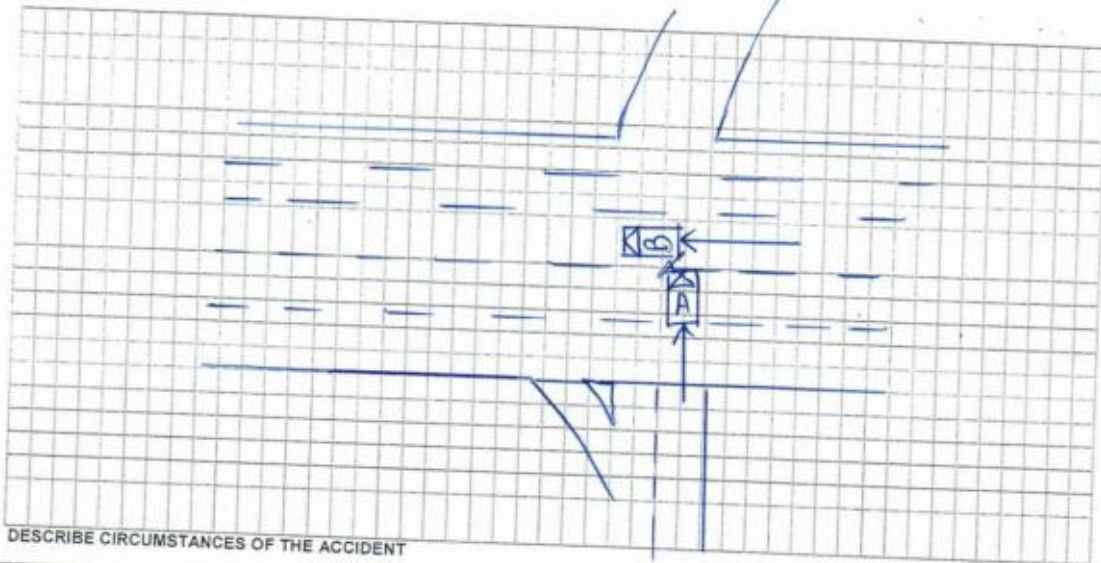

Brief Details.

I was travelling along Bencoolen Street in the direction of Fort Caning Road. I stopped at the junction of Bencoolen Street and Bras Basah Road in the right most lane as the traffic light was red. A taxi stopped in the red lane to my left. Then from the left side I saw the traffic light turn green so I moved forward. My car was not travelling fast as I have just moved out of the junction travelling probably at about 20 at most 30 to 25 km/h. My car hit the side of a black Mazda car SLM7665A that was travelling in the 3rd lane of Bras Basah Road, a 5 lane road. I saw the Mazda car turned 180 degrees. The position from the stop position at the traffic light o the site of approximate collision is about 15 to 20m. I stopped immediately. I got out of my car and found the driver of the other car already out of the car. He was unharmed and was walking about without issue. He denied pain or discomfort. Mr Toh Chin Hup S6940251H, the driver of the other car initially told me he was in a rush to 'fetch' a passenger as he was a Grab driver and will come back to settle with me. I said alright. We exchanged names and phone numbers near my car, some distance from Mr Toh's car. I was in a daze and my hands were trembling from fright. I told Mr Toh that I will move my car forward as it was in a position that was posing a danger to oncoming traffic. I sat in the car to call for tow assistance and to inform my family. Then an ambulance personnel came up to me to ask if I was alright. I was surprised that someone had called an ambulance as both Mr Toh and I were not injured. I did not realise and the driver did not make it known to me that there was a passenger seated on same side as the driver of the Mazda car till the arrival of the ambulance. The female passenger, Yang Yamei (name provided by Mr Toh Chin Hup) was able to get out of the car by herself and was transferred by

wheelchair to the ambulance.

The impact caused the side of the Mazda to be scratched and dented. The internal integrity of the car doors were not compromised. The car windows were not shattered and the air bags were not deployed. The front of my car was damaged. Air coolant leaked. I was still able to start my car after the accident. After the accident I realised that there were 2 sets of traffic lights at that junction. I then realised that the first set of traffic light that turned green was actually for the filter lane on the extreme left lane but this traffic light was a complete green disc and not the usual green arrow for filter lanes. That explained to me why I thought the light had turned to my favour and had moved out of the lane thus causing the accident.
