- On 22/4/2017 at 5.23pm or about 5.45pm, I was driving along BKE towards Woodland Checkpoint on the second lane when I signaled right to filter into lane one, and joined the queue of cars after easing into the said lane. At the point of time, car traffic was heavy and was stop-startish
- 2. Whitst waiting in my cat, I could hear some commotion near the rear of my vehicle, and elighted to see what the matter was. It appeared that a couple of Mataysia registered motorcycles were involved in what appeared to be an accident with a Singapore registered car at Lane 2. As I did not witness the accident, I was uncertain how the events had occurred. But I did notice that a mate Chinese, whom I believed was one of the riders of the Malaysian registered motorcycles, appeared to have some bruises and was sitting on the road.
- 3 The driver of the Singapore registered vehicle subsequently mentioned to me that the rider presumably a Malay, of the other Malaysian registered motorcycle, had asked him for monetary compensation for the purported injuries that he had sustained. I advised him against doing so and that he should let the authorities handle that
- The driver of the Singapore registered vehicle also asked me # I could recommended him workshop in John Bahru to repair his car. Again: I told him he should report to his insurance company as his vehicle was a rented car

5. Perceiving that police intervention was necessary, I called 395 to report on the accident, waited at scene, and co-sperated with the investigation.
My contention in this matter is that:
The switching of lanes was conducted without any incident, coupled with needful caution. The congration that was building up at that time of the day. B. It was not accosted by any of the affected series which would have provided me fair defense at that point of time. C. Litendered essistance where possible, and was also the one who contacted the police.
In view of the above circumstances, I urge you to consider my appeal against this traffic offence notice.


