Hi Mr Ronald,

Yes. We have viewed the accident scene and understand the circumstances of accident, the junction is wide for vehicle turning but generally accidents are caused mainly due to the road users.

We have repeatedly viewed the video from both sides and have the following observations to comments: -

- Based on your video: we noticed that your vehicle had made a sharp turn immediately after the stop line and kept too close to taxi's path. Your vehicle should keep more to the left as the turning radius is wide and follows the travelling route of front yellow taxi, the accident is avoidable.
- Based on Third party's video: The taxi is seen keeping to the right most lane before turning right, while proceeding within its lane, your vehicle appeared from the left and turned too close towards taxi's lane.

If you insisted that we should not offer settlement to the third party, kindly let us know within the next 14days i.e. by 30/01/2019 and we will seek further instruction from AIG.
