Accident Report

I was at the Jalan Seh Chuan public carpark at around 6:10pm on Saturday 7th of April, 2018 driving a white Honda Jazz (SJA5863U). I was turning left out of my carpark lot that was perpendicular to the Chun Tin Road side. A black Porsche (car plate SKR7813) was parked on the same side as me, one lot apart from me. I had turned out and was parallel with Chun Tin Road, perpendicular to the Porsche. I had not been fast enough to straighten my car after I turned out of the parking lot, and as I was driving too closely to the parking line, and the black Porsche was jutting out slightly from the lot, I scraped the front right side of the black Porsche (which was on my left). This resulted in some paint scratches on the top of the front right bumper of the black Porsche as well as a minor dent at the bottom of the front right bumper.

Following the accident, I got out of my car and took photos of the damage that was done to the black Porsche. As the car owner was nowhere in sight, I wrote a note, leaving my phone number for the driver to contact me, and left it on his windscreen (photo below). Seeing that he had an invehicle camera unit, I also made sure to motion to the camera that I had left a note on his windscreen. I have attached photos of the damage done to both cars, as well as my own.
