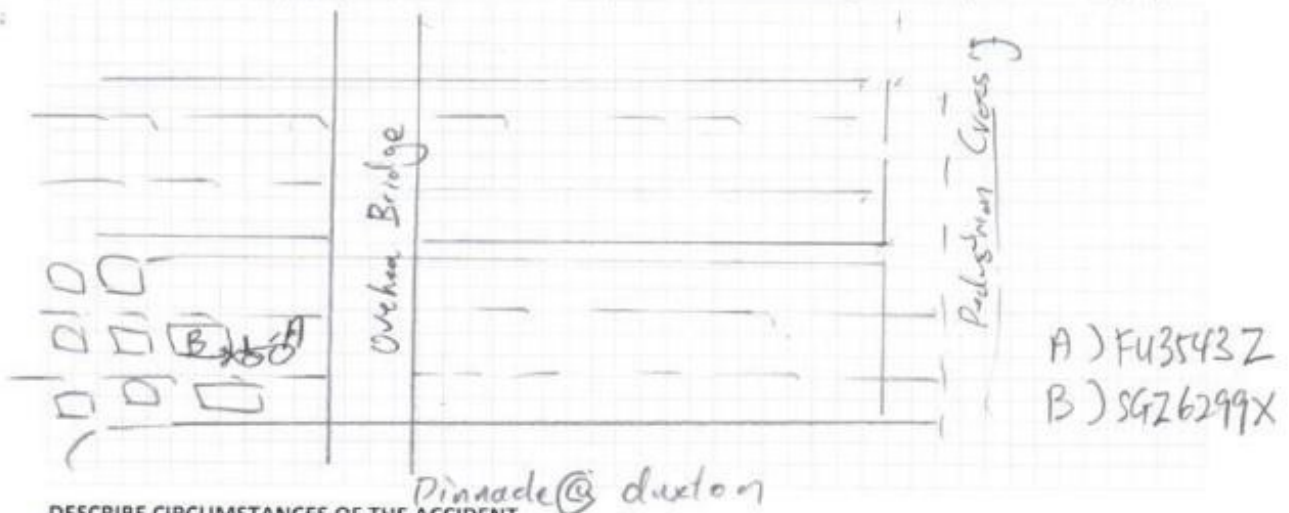

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

It was on the 10 of April 2018 around 10:10 pm. I was on my way to work. The weather is fine and road condition was dry. Traffic was heavy as it was the morning peak hours into the CBD along Cantonment Road.

I had just moved off from the previous traffic light and saw a traffic in front. The lights at the next junction had just turn green and the traffic ahead was moving.

The vehicle SGZ6299X in front, a white Suzuki Vitara was moving off as I have seen the brake lights went from light up to off. However, I quickly realize that the Suzuki is taking an unusually long time to move off although the brake lights are no longer on.

I quickly applied my brakes but was unable to stop in time and hit on the rear left side of the car's bumper. It made a small scuff and my bike fell down. No one was hurt in this accident.
