OI reported that OID was travelling on the main road turning right into the condo. While making a turn , TP vehicle from the minor road turn out and collided to the right rear of his vehicle.

TP reported that he was coming out from the condo(minor road), OID on the main road made an illegal u-turn without signal and front side of his vehicle was hit by OI.

We have requested for any evidence from TP repairer and there was no evidence provided.

In view of the above, we would like to reject TP claim as per bola 9(c) Vehicle turning from the major road into minor road have the precedence over vehicle turning from minor road to major road.
