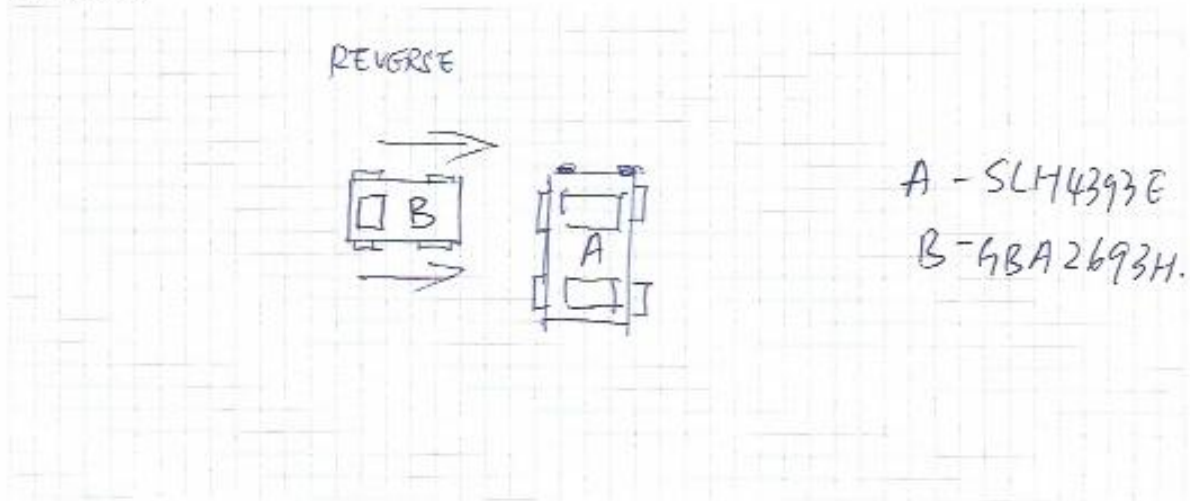
(e) the information so collected under (d) above may be shared / disclosed:
