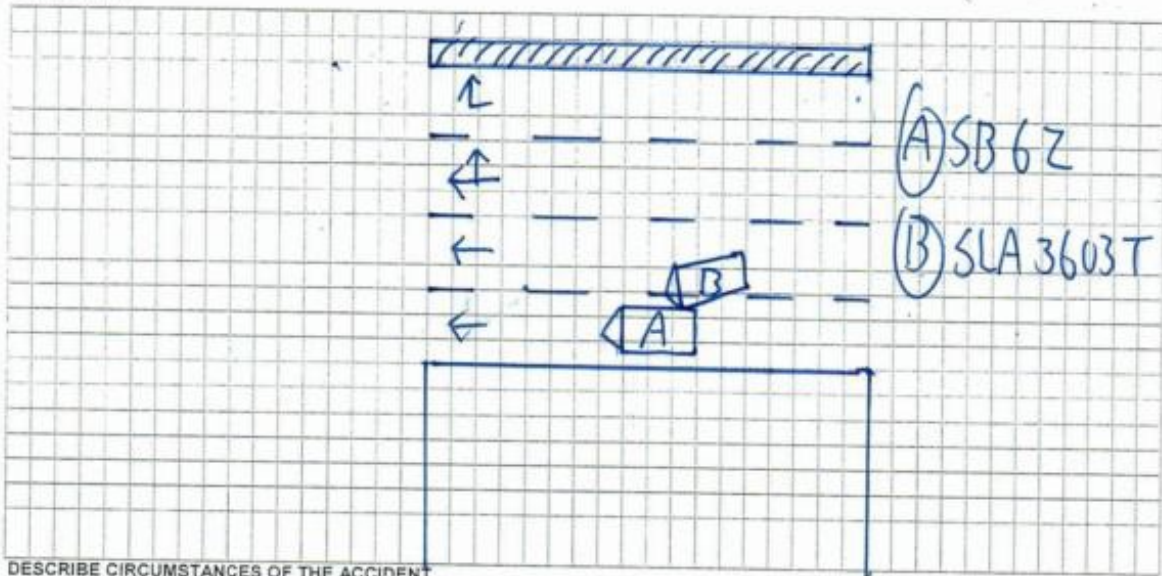

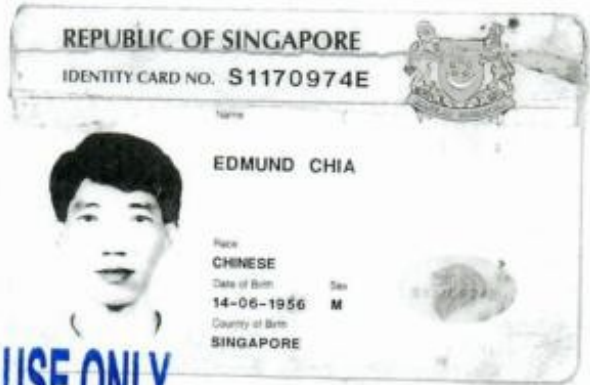
### Important note

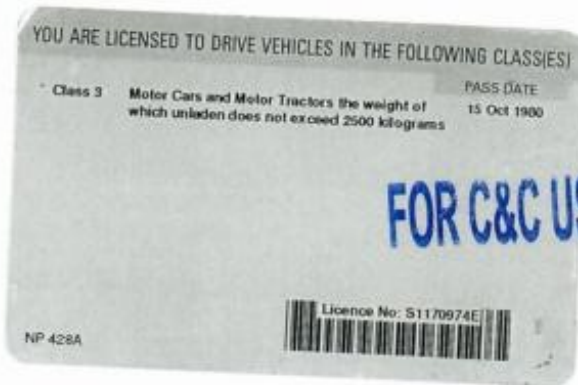
