

## Statement (Pg 1/1)

- Traffic accident between XD9117H and SGK3183U happened on 09-April-2018 at 4pm near LP65 along Eunos Link towards Hougang Ave 3 direction.
- Traffic condition was congested as there were road works going on lane 3, XD9117H on lane 3 was blocked by a public bus which was occupying lane 2 and lane 3.
- Driver of XD9117H checked left view mirror and there were no vehicles present on lane 4. However, unknowingly to driver of XD9117H, SGK3183U was stopped beside the front left side (blind spot) of XD9117H, and during the process of changing from lane 3 to lane 4 to overtake the public bus, the traffic accident occurred.
- No physical injuries were present for both the drivers of XD9117H and SGK3183U. Scratch marks found on front left bumper and behind front left tyre of XD9117H. Indentation found on right rear passenger door and above right rear tyre of SGK3183U.

**Photo of Post Accident Condition of XD9117H** 




**Location of Accident**
