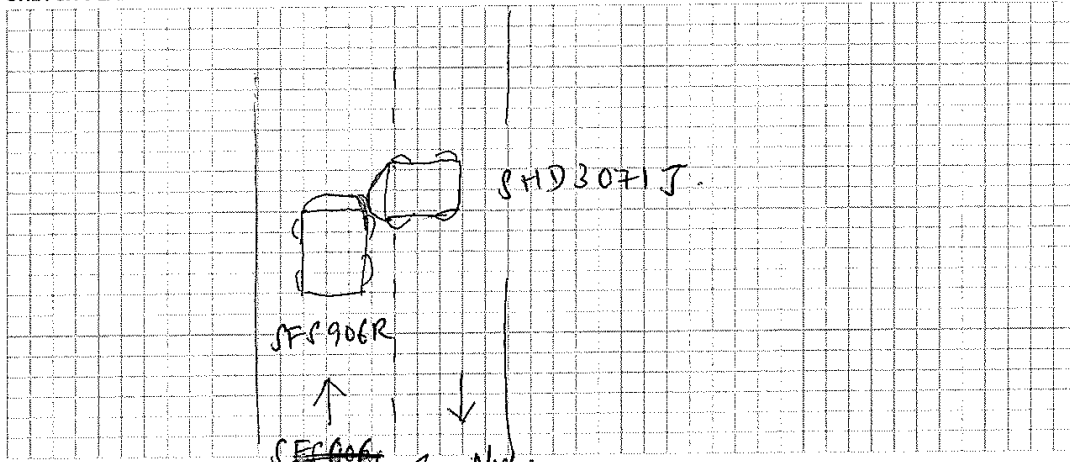

~~I~~ I pressed the horn but the taxi still turned and hit my car.

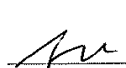
