Circumstances of Accident

Collision - Head to Rear (A third party vehicle hit me), #straightroad, Moving within lane (Side swipe including at bend) & Moving within lane (Side swipe including at bend) Blue Car GBE6228X, White Car SGZ3283K "On 4/4/18 evening, Mark was driving my car with my consent and authorization. He was driving along Ang Mo Kio Ave 4 towards AMK Ave 5. As He was near the junction of AMK Ave 4 / Ave 5, a white van which was behind and on the left of the car wanted to keep right. It turned right too quickly before the car was out of his way and so hit the left side of the rear of the car. The left rear of the car was swiped with scratch marks on the left side of the bumper. Because the van had hit the car at a low speed, it did not suffer any damage. There were some scratch marks on the black bumper which were not visible. As there were no damage to both vehicles and also no injuries sustained, Mark informed the van's driver no need to report the accident and consider the accident settled. The van's driver also agreed not to report. Later the van's owner, a car rental company sent the car for repair and made a third party claim without informing me. This is wrong because the van was not damaged in the accident and the owner is taking advantage of the situation by aggravating the scratches. Furthermore the driver already agreed there were no damage. Please investigate this case and do not let the other party claim against me. Thank you!"

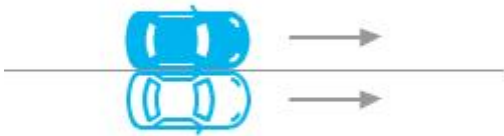
