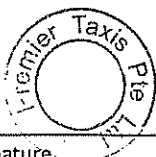
SKETCH PLAN

PATH ON MY LEFT ABRUPTLY & COLLIDED ONTO THE LEFT FRONT OF MY TAXI.

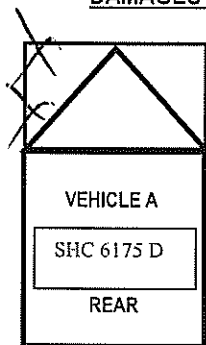
DUE TO THE IMPACT, MY TAXI HAD DAMAGES ON THE LEFT FRONT & AND VEHICLE

NO INJURY INVOLVED.

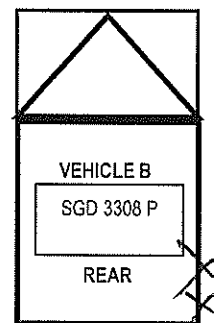
