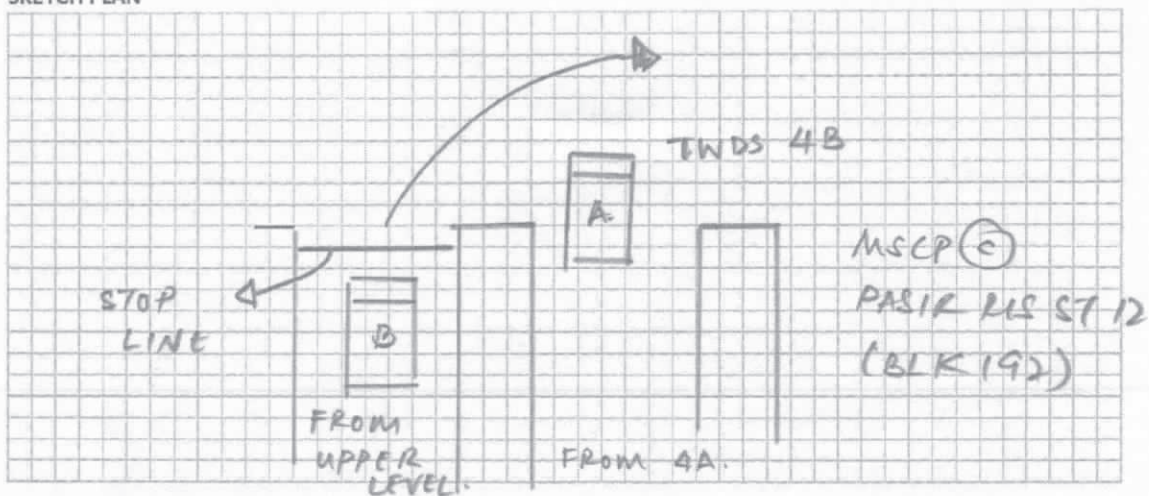

Describe Circumstance of the Accident.

ON 15/04/2018 @ 1455 HRS, I WAS DRIVING MY TAXI (SHB 8783 R) ALONG THE MULTI STOREY CARPARK @ PASIR RIS ST 12 (BLK 192).

WHILE I WAS MOVING AHEAD TOWARDS THE UPPER LEVEL, SUDDENLY VEHICLE B (SGJ 2215 Z – PTE CAR/WHITE) WHICH WAS FROM THE UPPER SLOPE (ON THE LEFT) – FAILED TO KEEP FOR PROPER LOOK OUT & FAILED TO STOP AT THE STOP LINE, HAD MOVED OFF AHEAD & CUTS ONTO MY PATH ON MY FRONT ABRUPTLY.

AS SUCH, THE RIGHT REAR OF VEHICLE B COLLIDED ONTO THE FRONT PORTION OF MY TAXI.

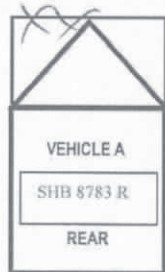

NO INJURY INVOLVED.

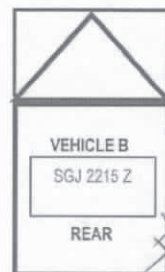
