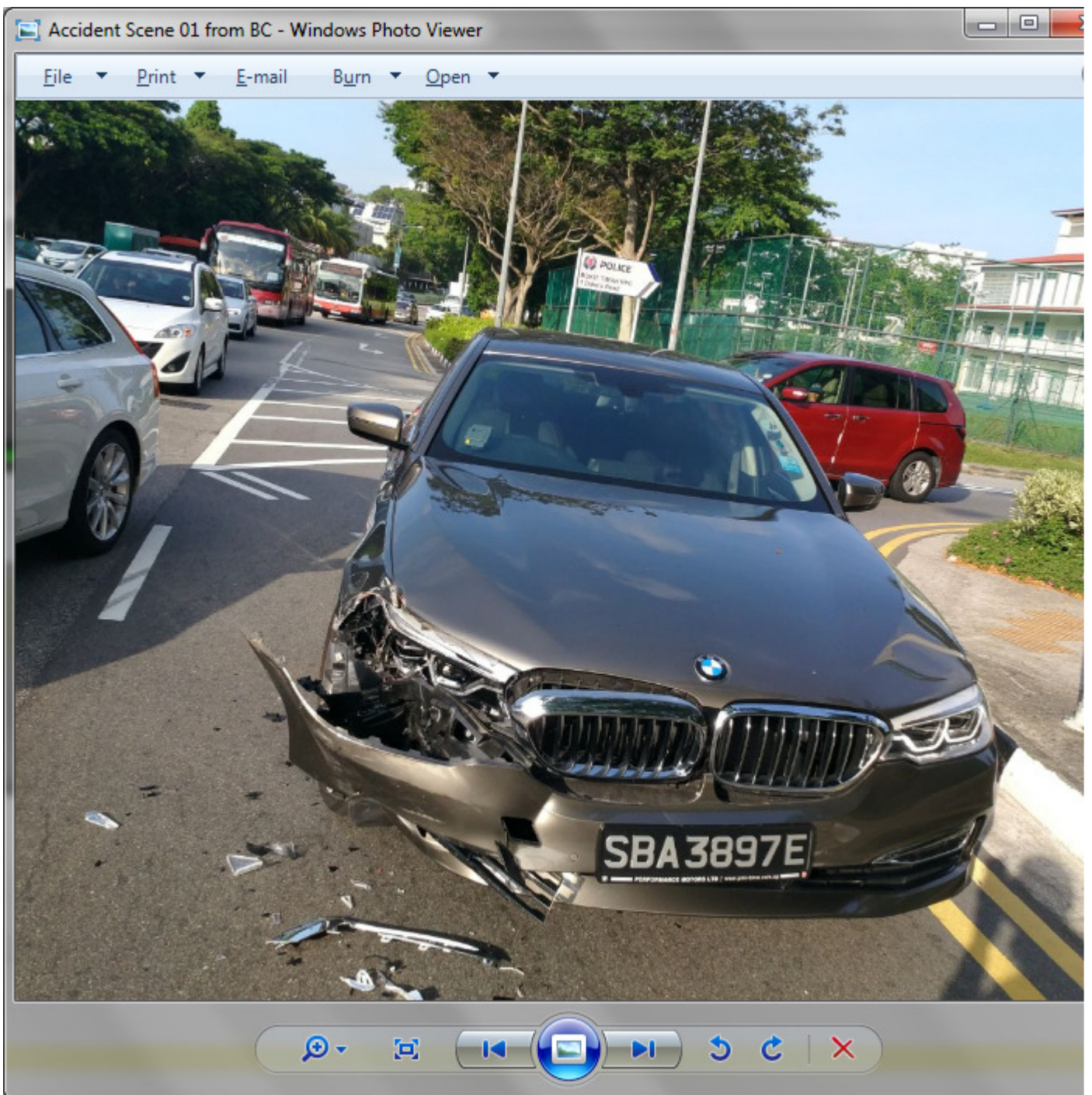
This is an April accident and video footage had been overwritten by now.  
What remained are the on-records accident scene snapshots, as attached above.

Based on AXA's GIA sketch, its insured driver reported that his car SBA3897E had already fully straighten itself, fully within left most lane on the major road, when bus filtered lane to hit SBA3897E. However, accident scene photos proved that this was not the case.

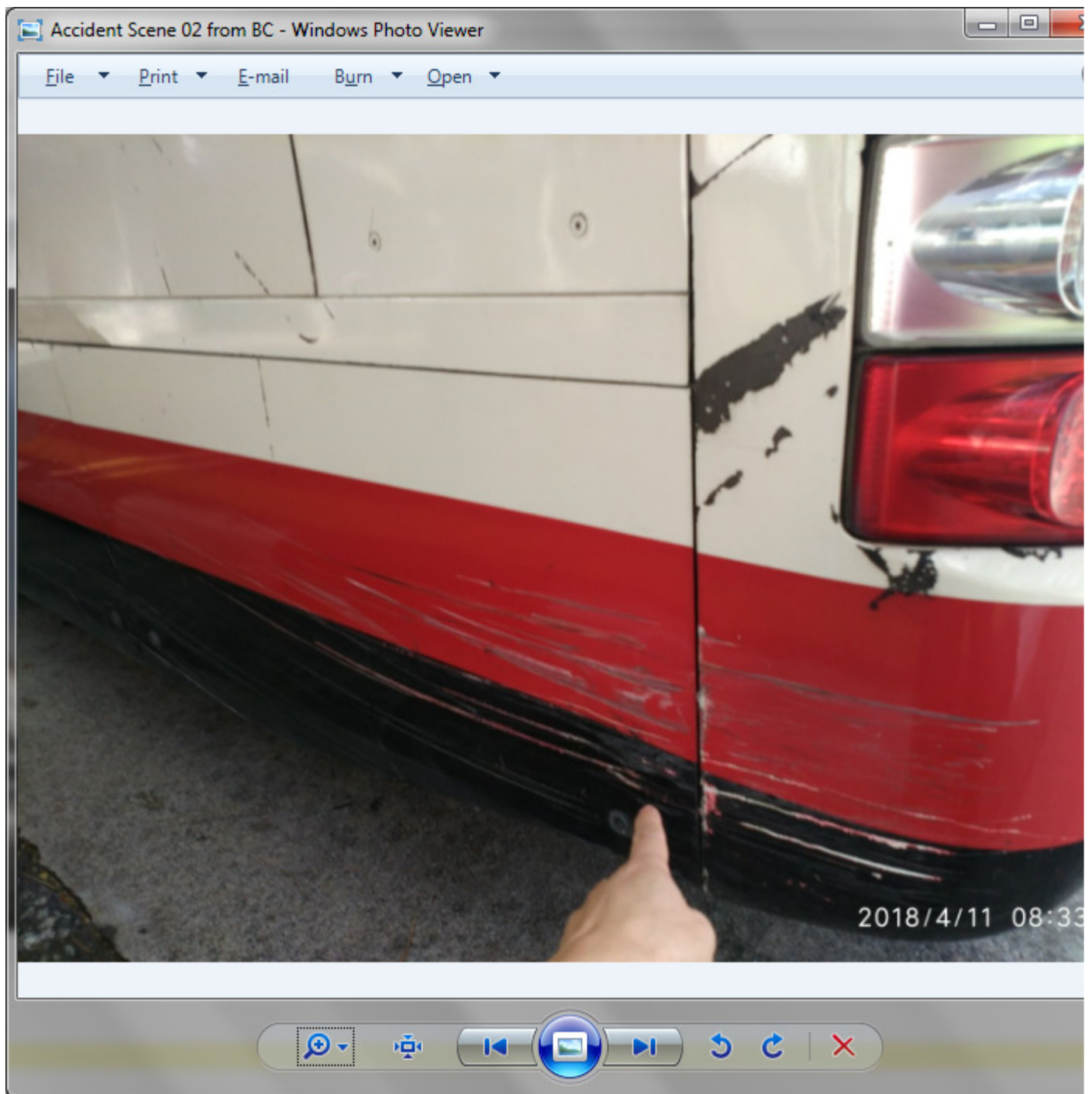
Accident scene photos proved that **SBA3897E's car body** was predominantly **still on the slip/minor road**, with its front bonnet jutting out beyond the white waiting line. It is the liability of cars coming out from minor/slip road to ensure clearance of oncoming vehicles from the major/main road, before turning out from the slip road. Instead of waiting behind the white line , **SBA3897E's front bonnet was already surging beyond the white line, encroaching into the main road**. Bus was travelling rightfully within its bus's lane, going into bus stop on the major road.

This accident would not have occurred had AXA's insured vehicle SBA3897E not surge out into main road, encroaching into bus's lane. We deemed full liability on SBA3897E under Bola S1.

As supported by accident scene photos attached above, its undeniable that AXA insured car SBA3897E came out from the slip road to hit unto bus, while bus was travelling on the major road. The collision took place while SBA3897E car body was still on the slip road. This is really a Bola S10 scenario as supported by photograph evidence, and not a Bola S15 as proclaimed by SBA3897E's sketch. We therefore deemed full liability on SBA3897E and maintained 100% of our claims.
