We would like to highlight to you that pursuant to paragraph 2.4 of Pre-Action Protocol for NIMA Cases, we have agreed to appoint AXA's surveyor ie. LKK Auto Consultants Pte Ltd as Single Joint Expert (SJE) and the cost of repair has been finalised by your surveyor at a lump sum repair of S\$17,000.00 (excluding 7% GST). 


