CIRCUMSTANCES OF THE ACCIDENT:


Time: About 1215 hrs, Sun 15 Apr 2018

Road: PIE Tuas towards the direction of Jurong, before Exit 22 towards Eng Neo Avenue

Insured vehicle: Toyota Camry 2.0 SGUH998A (Driver: S8138016C Yap Wen-We Eugene)

Other vehicle involved in accident: Comfort-Delgro Hyundai i40 SHA7633C (Driver: S812142E Chan Choon Juay)

On Sun 15 Apr 2018, at about 1215hrs, I, S8138016C Yap Wen-We, Eugene, was driving the insured vehicle, Toyota Camry 2.0 SGUH998A, along PIE Tuas towards the direction of Jurong. I signalled left to change lanes in preparation to exit the expressway at Exit 22 towards Eng Neo Avenue. As I was changing lanes to the left in preparation to exit the expressway at Exit 22 towards Eng Neo Avenue, after checking the left-side mirror, I heard a loud knock and realised that the insured vehicle's left-side mirror had been hit by another vehicle. I noticed from the corner of my eye that it was a blue taxi, which had hit the insured vehicle's left-side mirror. As there were many fast-moving vehicles on the expressway, I pulled up along the road shoulder some distance ahead before Exit 22. Shortly after, Comfort-Delgro Hyundai i40 SHA7633C driven by S812142E Chan Choon Juay pulled-up behind the insured vehicle. The insured vehicle's left-side mirror was hit by Mr Chan's vehicle's right-side mirror such that the ~~the~~ insured vehicle's left-side mirror was bent forward, and cracked at the bottom. Mr Chan's vehicle's right-side mirror was also damaged. No injuries were sustained by either party.
