

CONTINUATION OF REPORT

Brief Details.

On 11/04/2018 at about 1550hrs, I was driving my vehicle bearing registration number SKK5140H along Toh Tuck Road towards Bukit Batok East Ave 3. It was a two way road and in front of my vehicle, there was a bus. The bus finally come to a stop at one of the Bus stops near Signature Park Condominium and I was not able to go through as the bus covers the whole lane. I then decided to check for any oncoming cars, right side mirror and my right blind spot before inching right intending to overtake the bus from the right. However, before I could do so, a car suddenly side swiped my car on the right side and overtook the bus.

The other car stopped a distance ahead however I was not sure whether there was any damages on our vehicle hence I decided to make a turn into Toh Tuck Terrace as I intended to go to Necessary Provision Caf which is at Eng Kong Terrace. I saw the other car drove off as I was turning into Toh Tuck Terrace. Later that day, I realized that there was scratches on the right side of the car. I settled the matter on my own as I was not sure that I needed to lodge a Police report nor was I able to trace the other party's vehicle.

On 24/04/2018, I received an email from Traffic Police that a Traffic Accident Report was made against me hence I am lodging this Police Report.


