

Yes, our Insured taxi was reversing, however, your client's vehicle was exiting from a minor road. Both parties should exercise caution.

Describe Circumstances of the Accident

On 19 June 2015 @ about 18:05hrs, my taxi was reaching the front of No. 1 Oei Tiong Ham Park for my
current booking. My taxi was stopped to check the traffic around, I saw Veh B come from the junction ahead
After Veh B passed by my taxi, and confirmed there was no other traffic, my taxi reversed into the entrance
of No. 1 Oei Tiong Ham Park. When reversing, unexpectedly, Veh B was reversed into the same location
with a pretty fast speed. As a result, my taxi left rear corner hit to Veh B right front door.
I would like to state that the entrance of house is wide enough for more than 2 vehicles, but Veh B did not
keep within his lane and caused the accident.
No pax on board and no injury involved in the accident as my speed was about 10km/hr.


We do not agree to your 50% in liability.
