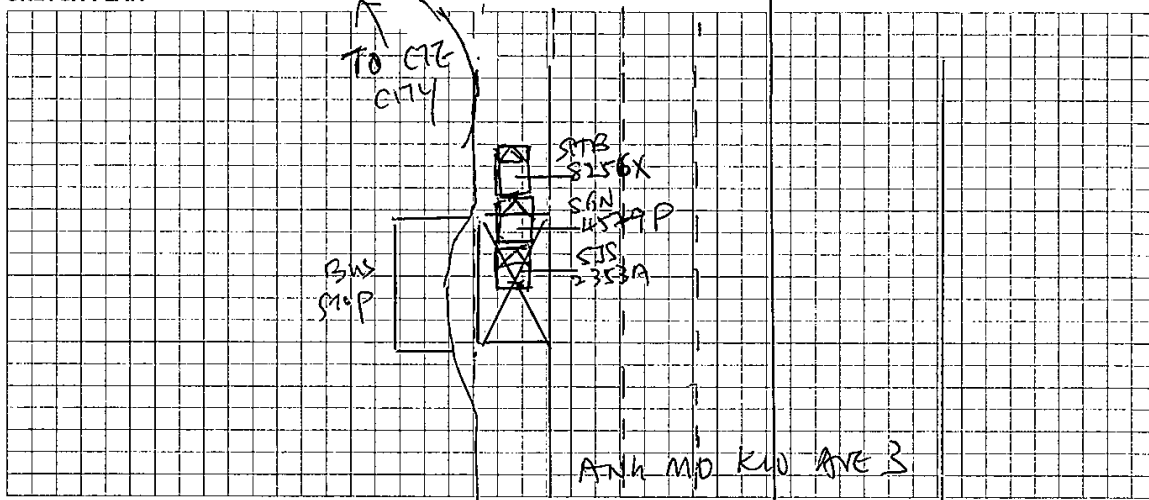

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

ON 21-4-2018 AT ABOUT 1300 HRS, I WAS DRIVING IN A ROW OF VEHICLE ALONG ANK MO KLO AVE 3 HEADING TOWARDS CTE ON MY LEFT MOST LANE, WHEN AFTER PASS THE BUS STOP IN FRONT, THE TAXI IN FRONT OF ME SLOW DOWN TO A STOP, I FOLLOW AND STOP. THE MOMENT I STOP MY VEHICLE, IMMEDIATE I FEEL AN IMPACT FROM THE REAR OF MY VEHICLE AND CONTINUE TO ANOTHER IMPACT AGAIN, THE IMPACT PUSH MY VEHICLE FORWARD AND HIT ONTO THE VEHICLE STB 8256X, UPON ALIGHTING AND REALISED THAT VEHICLE SJS 2353A CANNOT STOP IN TIME AND COLLIDED ONTO MY VEHICLE REAR.
