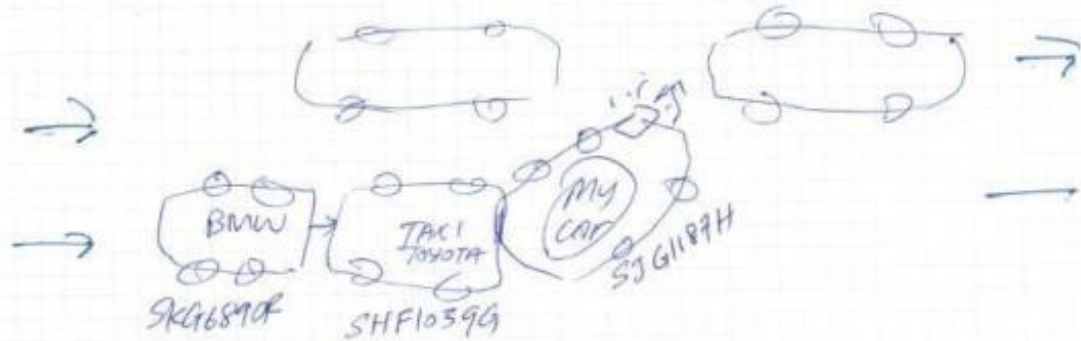

### DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 24.4.18 about 0924, I was travelling at PIE towards Tunas near Tol Tuck exit 27 (2nd lane from the left). I was signalling left and waiting for space to go into the left lane.

I was moving slowly and subsequently slowed down to a stop due to traffic jam while waiting to go to the left lane. Suddenly after a few seconds I felt an impact coming from the rear of my vehicle (SJG1187H). I alighted and found out that (SHF1039G) had moved forward and hit my vehicle (SJG1187H). My vehicle was not damaged.

When I reviewed the car camera (in-built), it was clear that (SHF1039G) moved forward due to impact from (SKG6890R).

Thankfully nothing has happened. There were no injury, no ambulance or traffic police at scene.
