Luckily, I am still able to control the speed of my vehicle SJQ5343U to avoid serious accident at this raining day and slippery road. By right the vehicle SLD9538T which totally out from the white line and junction should not apply emergency break because this will cause danger to other users. I believe that the driver of SLD9538T is a grab driver and checking on the phone looking for location. Therefore, the driver of SLD9538T didn't concentrate during his driving time.
