

Brief Details.

On 23/04/2018 at about 1515hrs, I was driving vehicle (SJH5114L) along Choa Chu Kang Drive before Choa Chu Kang Park going toward KJE. It was raining that day and the road surface was wet. While approaching the junction, the traffic light suddenly turned to amber hence the vehicle (SHD3606S) applied brake to his vehicle (SHD3606S). I applied brake to my vehicle (SJH5114L) as well and managed to stop my vehicle (SJH5114L) in time.
