Accident Sketch Plan





DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 26/02/18 as I was traveling on Tuas West Road towards Jln Ahmad Ibrahim, the lorry was stopped in front of my vehicle on a 4-lane road on the extreme right lane. All 4-lanes are traveling straight before heading to the next traffic light to turn right into Jln Ahmad Ibrahim. ^{while negotiating the right turn} The lorry in front skidded and hit on to the right kerb and stopped immediately. I could not stop the vehicle in time and collided into the lorry. The driver kept apologizing it wasn't his fault as the vehicle front tyres are quite wore out and his vehicle skided. On inspecting this vehicle front ~~two~~ three tyres are wore out.
